That the expenditure of \$87,100.00 is hereby authorized out of Water Bond Fund 720 of The City of San Diego, solely and exclusively for the purpose of acquiring fee title to portions of Sections 5, 8 and 17, Township 13 South, Range 2 West, San Bernardino Base and Meridian, required to eliminate a privately owned island surrounded by City ownership in the Lake Hodges area.
