BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of DEPARTMENT OF VETERANS AFFAIRS OF THE STATE OF CALIFORNIA and RALPH W. COPP, JR. and JANET E. COPP, husband and wife, executed in favor of The City of San Diego, bearing date July 13, 1971, conveying to said City an easement and right of way for street purposes through, over and across that portion of Lot "L" of La Mesa Colony, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 346, filed in the office of the County Recorder of said County, together with an easement and right of way for an earth excavation or embankment, slope or slopes, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 70TH STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
