

RESOLUTION No. 203556

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THOMAS H. FOX and DONNA B. FOX, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date July 22, 1971, conveying to said City an easement and right of way for street purposes through, over and across that portion of Lots 12 and 13 of Blethen Subdivision, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 2259, filed in the office of the County Recorder of said County, August 22, 1941, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 70TH STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
