

RESOLUTION No. 203557

Adopted on AUG 26 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MILDRED M. GENTRY, a widow, executed in favor of The City of San Diego, bearing date July 23, 1971, conveying to said City an easement and right of way for street purposes through, over and across that portion of the Southerly 50.00 feet of Lot 11, the North line of said Southerly 50.00 feet being parallel with and distant 50.00 feet at right angles North from that portion of the Southerly line of said Lot 11, which has a bearing of North 89° 07' 00" West in Blethen Subdivision, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 2259, filed in the office of the County Recorder of said County, August 22, 1941, together with an easement and right of way for an earth excavation or embankment, slope or slopes, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 70TH STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
