WHEREAS, The City of San Diego and the operating agencies desire to amend their agreements to simplify budget adjustments; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. Project Budget
 - a. Personal
 - b. Nonpersonal expense and outlay.
2. Salary and Position Schedule
3. Estimated Monthly Expenditure Schedule.

BE IT FURTHER RESOLVED, that the amendments provided for herein shall in no way alter, increase or decrease the total budget heretofore approved for each operating agency.
