

RESOLUTION NO. 203581 AUG 31 1971

WHEREAS, The City of San Diego is the owner of a street reservation affecting a portion of Lot 1, Greenwood Memorial Park Unit No. 1, according to Map thereof No. 6056, filed February 29, 1968, in the office of the San Diego County Recorder; and

WHEREAS, Greenwood Cemetery Association of San Diego, a corporation, has requested that the City quitclaim to it its interest in and to a portion of said street reservation so that it can be properly developed with the adjacent cemetery property; and

WHEREAS, Greenwood Cemetery Association of San Diego has granted the City slope rights and street light easements in connection with the Imperial Avenue improvement; and

WHEREAS, a portion of said street reservation is not needed for any present or prospective City use and the City Engineer has no objection to the quitclaim of a portion of said street reservation; and

WHEREAS, a portion of said street reservation in said portion of Lot 1, Greenwood Memorial Park Unit No. 1 should be quitclaimed to Greenwood Cemetery Association of San Diego; and

WHEREAS, the City Manager recommends that said portion of said street reservation be quitclaimed to Greenwood Cemetery Association of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property right described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 737210, be, and the same is hereby authorized to be quitclaimed to GREENWOOD CEMETERY ASSOCIATION OF SAN DIEGO, a corporation.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 737210, quitclaiming to GREENWOOD CEMETERY ASSOCIATION OF SAN DIEGO, a corporation, a portion of a street reservation across a portion of Lot 1, Greenwood Memorial Park Unit No. 1, as more particularly described in said form of quitclaim deed.

3. That the City Clerk of said City is hereby authorized and directed to deliver said deed to the Property Director for further handling.
