BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of BAYLOR CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date July 19, 1971, conveying to said City an easement and right of way for water purposes, through, along and across portions of Section 23, Township 14 South, Range 3 West, San Bernardino Base and Meridian, according to the United State Government Survey, approved May 20, 1884, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
