BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that quitclaim deed of THE UNITED STATES OF AMERICA, executed in favor of The City of San Diego, bearing date July 10, 1971, quitclaiming to said City portions of Pueblo Lots 1179, 1180, 1189 and 1190 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the office of the County Recorder of said County of San Diego, November 14, 1921, as Miscellaneous Map No. 36, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
