BE IT FURTHER RESOLVED, that the expenditure of \$10,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for soils engineering services as described above and related expenses, supplementing Resolution No. 200314 in that amount.
