BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$22,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the construction of alternate greens at Torrey Pines Golf Course.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for the construction of alternate greens at Torrey Pines Golf Course, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
