BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Water Easement deed of the San Diego Gas and Electric Company, a corporation, executed in favor of The City of San Diego, bearing date April 26, 1971, conveying to said City an easement and right of way for water purposes, through, along and across a portion of Lot 7 in Pueblo Lot 1113, according to Map No. 875, entitled "Plat of Lot 32 Ex-Mission Rancho and Part of Pueblo Lot 1113 in San Diego County, California", made in October, 1899 by G.A. D'Hemecourt, filed in the office of the County Recorder of said County of San Diego, July 10, 1901, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
