BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$28,825.30 by Aztec Paving, Inc., a corporation for the CONSTRUCTION OF CONCRETE INVERT LINING OF THE MURRAY RESERVOIR DITCH PHASE II (WEST SIDE - MURRAY DAM TO JACKSON DRIVE) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 736402.
2. That the expenditure of \$33,000.00 is hereby authorized out of the Water Revenue Fund 502 of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF CONCRETE INVERT LINING OF THE MURRAY RESERVOIR DITCH PHASE II (WEST SIDE - MURRAY DAM TO JACKSON DRIVE) in the City of San Diego, and related costs.
