

RESOLUTION NO. 203623 SEP 2 1971
APPROVING MAP OF CERISE SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by W. R. NOTHOMB, Licensed Land Surveyor, and entitled,
"CERISE SUBDIVISION Being a subdivision of Lots 5 through 18,
Block 17, Lots 19 through 22, Block 19, Lots 1 through 13 and Lots
25 through 40, Block 20, all of Blocks 21 and 22, together with a
portion of that certain Unnamed Lot lying between said Blocks above,
known as "Grant Circle" in Grantville and Outlots, in the City of
San Diego, County of San Diego, State of California, according to
Map thereof No. 776, filed in the office of the County Recorder of
San Diego County, February 16, 1894, together with vacated streets
and alleys.", is made in the manner and form prescribed by law
and conforms to the surrounding surveys; that said map and the
subdivision of land shown thereon is hereby approved and accepted;
and said Council hereby accepts on behalf of the public, the
portion of public street, to wit: portion of Rainier Avenue for
public purposes and said portion of street is hereby declared to
be portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf
of The City of San Diego, a municipal corporation, any and all
abutters' rights of access in and to the alley, Block 20, Grantville

and Outlots; Olympic Avenue and Crawford Street, all adjacent and contiguous to Lot 1, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
