BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by GUY W. WINTON, JR. Registered Civil Engineer, and entitled, "RESUBDIVISION NO. 1 OF SEVEN OAKS UNIT NO. 13 Being a resubdivision of a portion of Lot 1 and all of Lot 2 and Avenida La Valencia as dedicated to public use, in Seven Oaks Unit No. 13, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6423, filed in the office of County Recorder of San Diego County, July 18, 1969.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego those certain easements shown on Sheet 2 of this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and that those certain easements as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
