UNIT NO. 4, and portions of CARMEN STREET,

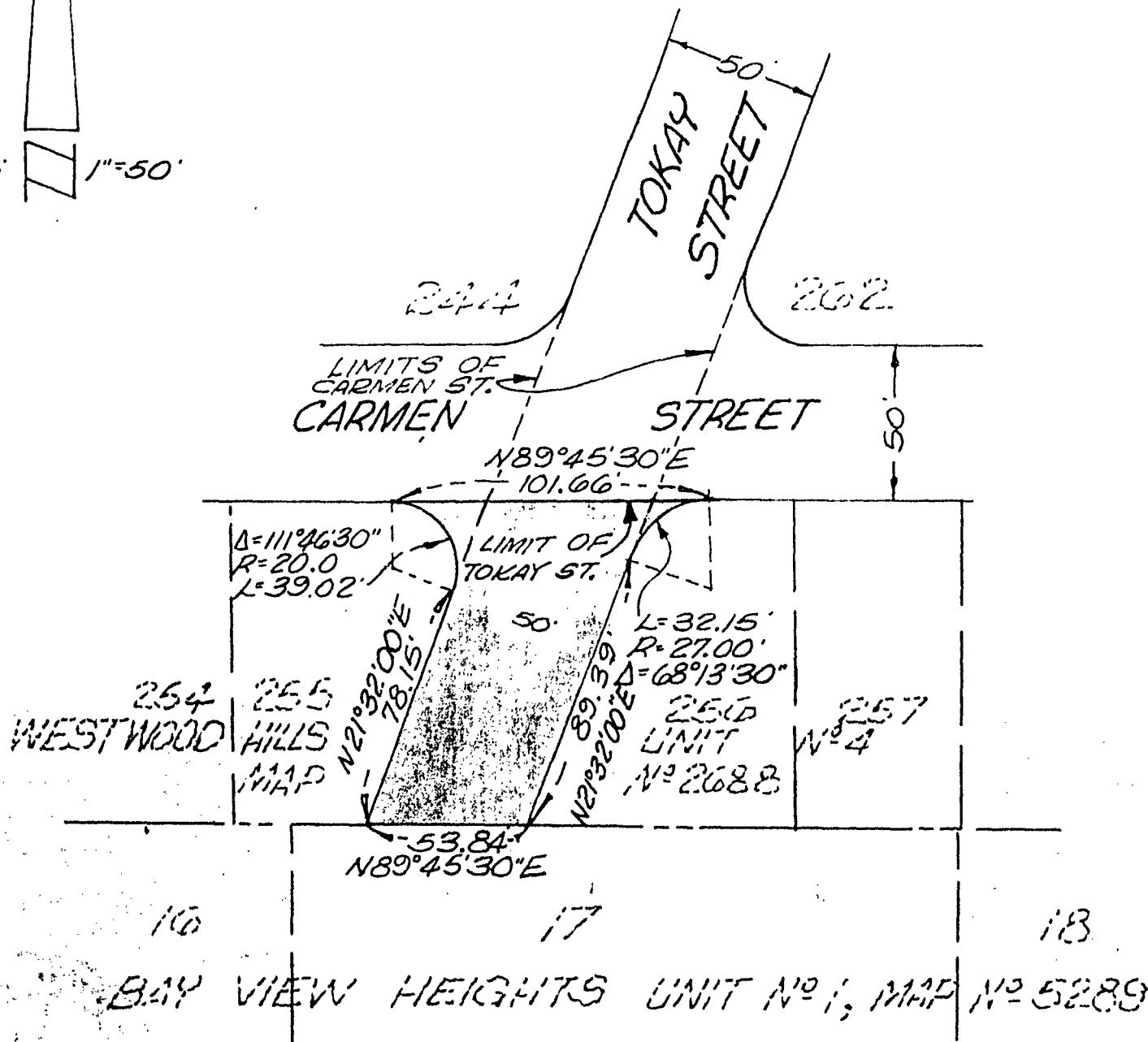
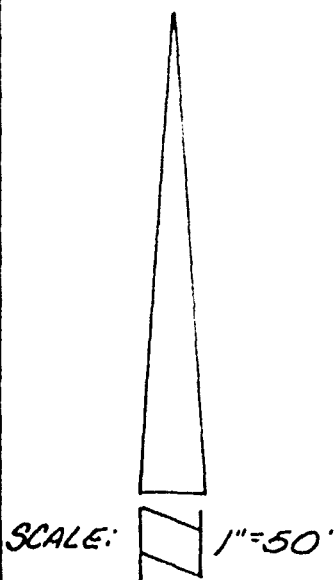
