as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "FRIARS PROFESSIONAL PARK UNIT NO. 2 Being a subdivision of a portion of Lot 4 of the partition of a portion of Pueblo Lots 1173 and 1174, in the City of San Diego, County of San Diego, State of California, according to Licensed Surveyor's Map thereof No. 170, filed in the County Recorder's Office of San Diego County, May 2, 1913. Together with a portion of Old Friars Road as vacated by the City of San Diego under Resolution No. 198922, a certified copy of which was recorded in the office of the County Recorder of San Diego County on January 22, 1970 as File No. 12829.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
