

RESOLUTION NO. 203666

APPROVING MAP OF VIEW TERRACE SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by DON NASLAND, Licensed Land Surveyor, and entitled,
"VIEW TERRACE Being a subdivision of portions of Pueblo Lots
1239 and 1777 of the Pueblo Lands of San Diego, in the City of
San Diego, County of San Diego, State of California, according to
Map thereof by James Pascoe in 1870, a copy of said map was filed
in the office of the County Recorder of San Diego County, November
14, 1921, and is known as Miscellaneous Map No. 36.", is made in
the manner and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown thereon is
hereby approved and accepted; and said Council hereby accepts on
behalf of the public the streets, to wit: Ariane Drive and Morena
Boulevard for public purposes, and said streets are hereby declared
to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, the
easements with the right of ingress and egress for the construction
and maintenance of sewer and drainage facilities as granted and
shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, the City of San Diego, a municipal

corporation, hereby accepts the open space easement over portions of Lots 1, 2, and 3 granted on this map, subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are hereby accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the open space easement granted on this map, are accepted on behalf of the City of San Diego, subject to the conditions set forth thereon.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
