

RESOLUTION NO. 203673 SEP 7 1971

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purpose of a right of way for a public sewer and appurtenances thereto; through, over, under, along and across the hereinafter described property, be, and the same is hereby set aside for such public purposes:


All that portion of Lot 3 in Block 27 of Rosedale, according to Map thereof No. 826 filed in the Office of the County Recorder of San Diego County, January 21, 1897, and a portion of Lot 43 of Rosedale Tract, according to Map thereof No. 825 filed in the Office of the County Recorder of San Diego County, January 21, 1897 together with a portion of that certain unnamed County road between said Lots 3 and 43 as vacated and closed to public use by Order of the Board of Supervisors of San Diego County on December 1, 1930, a copy of which was recorded December 4, 1930 in Book 1839, Page 217 of Deeds all being in the County of San Diego, State of California, more particularly described as follows:

Commencing at the Northwest corner of property conveyed to the City of San Diego in Deed recorded July 24, 1967, as File/Page No. 107514, Series 8, Book 1967, Official Records; thence South 09°08'59" East (record South 09°08'26" East), 183.38 feet to the TRUE POINT OF BEGINNING; thence continuing South 09°08'59" East (record South 09°08'26" East), 21.31 feet; thence North 60°37'16" East, 370.47 feet; thence North 17°30'16" West, 19.16 feet; thence North 89°39'41" West, 2.51 feet; thence South 60°37'16" West, 364.87 feet, returning to the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
