BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purposes of a public street through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street, and the same is hereby named BALTIMORE DRIVE:

All that portion of Lot 19 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Partition Map on file in the Office of the County Clerk of San Diego County in Action No. 348 in Superior Court of said County entitled "Juan M. Luco, et. al. vs the Commercial Bank of San Diego, et. al." together with portions, if any, of Lots 194, 195 and 196 of La Mesa Colony, also in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 876 on file in the Office of the San Diego County Recorder, more particularly described as follows:


Beginning at the Southeast corner of Lot 32, Lakeview Estates Unit No. 4, according to Map thereof No. 5711 on file in the Office of the San Diego County Recorder, said corner being a point in the arc of a 1,051.00 foot radius curve, concave North-easterly, a radial to said point bears South 65° 21' 32" West; thence Southerly and Southeasterly along the arc of said curve through a central angle of 04° 49' 32" an arc length of 88.52 feet; thence South 29° 28' 00" East, 395.75 feet to the beginning of a 1,949.00 foot radius curve, concave Southwesterly, a radial to said point

bears North 60° 32' 00" East; thence Southeasterly and Southerly along the arc of said curve through a central angle of 07° 49' 10", an arc length of 265.99 feet; thence South 21° 38' 50" East, 169.68 feet; thence North 38° 23' 25" East, 117.74 feet; thence North 21° 38' 50" West, 110.88 feet to the beginning of a 2,051.00 foot radius curve, concave Southwesterly, a radial to said point bears North 68° 21' 10" East; thence Northwesterly along the arc of said curve through a central angle of 07° 49' 10", an arc length of 279.91 feet; thence North 29° 28' 00" West, 395.75 feet to the beginning of a 949.00 foot radius curve, concave Northeasterly, a radial to said point bears South 60° 32' 00" West; thence Northwesterly along the arc of said curve through a central angle of 01° 41' 09", an arc length of 27.92 feet; thence North 87° 57' 30" West, 115.75 feet, returning to the Point of Beginning.

Basis of Bearings: Radial line and centerline of El Paso Street, La Port Street, Baltimore Drive, per Map No. 4761, i.e. (N 72° 20' 00" E).

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the Office of the County Recorder of San Diego County.
