

RESOLUTION NO. 203675 SEP 7 1971

WHEREAS, the Federal Highway Act of 1970 directed the establishment of a Federal-aid urban highway system, hereinafter referred to as "FAU System," for the San Diego metropolitan area; and

WHEREAS, Federal legislation provided that routes on the FAU System be selected by appropriate local officials in cooperation with appropriate State officials; and

WHEREAS, the Federal Highway Administration instructed that the FAU System be based upon the National Highway Functional Classification System of the Region, which system is subject to revision on a biennial basis; and

WHEREAS, the local agencies of metropolitan San Diego, in cooperation with the California Division of Highways, have selected a proposed FAU System within the 1970 Bureau of Census urbanized limits conforming to the instructions issued by the Federal Highway Administration; and

WHEREAS, the proposed routes of FAU Systems for the San Diego metropolitan area have been approved by the San Diego County Comprehensive Planning Organization (CPO); and

WHEREAS, The City of San Diego desires to approve the FAU System and have the State submit said approval to the Federal Highway Administration; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That The City of San Diego hereby approves the proposed FAU System selected for the City's portion of the San Diego metropolitan area as set forth in the maps on file in the office of the City Clerk as Document No. 737278

2. That The City of San Diego hereby approves any necessary changes as reflected on the maps as described heretofore in other Federal Aid highway systems required by establishment of the FAU System.

3. That the City Manager be and he is hereby authorized to submit, for and on behalf of said City, to appropriate officials of the State of California, such documentation of approval of the FAU System as set forth herein as may from time to time become necessary; and further, that the City Manager be and he is hereby authorized to request that the State act as Agent for said City to submit those plans as approved herein to the Federal Highway Administration.
