1. That the bid of \$183,837.50 by FCM Contracting Co., a partnership for the CONSTRUCTION OF SEWER MAIN REPLACEMENTS GROUP 8, (PHASE I CITY HEIGHTS) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 736400.
2. That the expenditure of \$216,000.00 is hereby authorized out of the Sewer Bond Fund 728 of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF SEWER MAIN REPLACEMENTS GROUP 8, (PHASE I CITY HEIGHTS) in the City of San Diego, and related costs.
