1. 2. That the expenditure of \$81,000.00 is hereby authorized out of the Gas Tax Fund (220) of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF BALTIMORE DRIVE BETWEEN BERTRO DRIVE AND EL PASO STREET, including Alternate II, in the City of San Diego, and related costs.
