

RESOLUTION NO. 203736 SEP 14 1971

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That an easement for the purpose of a right of way for a  
public sewer and appurtenances thereto; through, over, under,  
along and across the hereinafter described property, be, and  
the same is hereby set aside for such public purposes:

All that portion of Lot 9 of Rosedale Tract  
in the City of San Diego, County of San Diego,  
State of California according to Map thereof  
No. 825 filed in the Office of the County  
Recorder of San Diego County, being a strip  
of land 15.00 feet in width lying 10.00  
Easterly and 5.00 feet Westerly of the follow-  
ing described line:

Commencing at the Northeast corner of Villa  
Monserate Unit No. 1 according to Map  
thereof No. 6960 filed in the Office of the  
San Diego County Recorder on June 9, 1971;  
thence along Northerly boundary line of said  
Villa Monserate Unit No. 1, North 64°24'28"  
West, 51.00 feet; thence North 75°29'48"  
West 38.29 feet; thence South 62°24'22" West,  
10.55 feet to the TRUE POINT OF BEGINNING;  
thence North 08°57'58" West, 92.98 feet to a  
point of terminus in the Southerly boundary  
line of existing sewer easement per City  
Engineer's Drawing No. 14196-3-D.

The sidelines of the above described strip of  
land shall be prolonged or shortened so as to  
terminate Northerly in the Southerly boundary  
line of said existing sewer easement and  
Southerly in the Northerly boundary line of  
said Villa Monserate Unit No. 1.

BE IT FURTHER RESOLVED, that the City Clerk is hereby  
directed to file a certified copy of this resolution in the  
office of the County Recorder of San Diego County.
