

RESOLUTION NO. 203737 SEP 14 1971

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for a
public sewer and appurtenances thereto; through, over, under,
along and across the hereinafter described property, be, and
the same is hereby set aside for such public purposes:

All that portion of Lot 9 of Rosedale Tract
in the City of San Diego, County of San
Diego, State of California according to
Map thereof No. 825 filed in the Office of
the County Recorder of San Diego County
more particularly described as follows:

Commencing at the Southeast corner of Lot
100A of Villa Monserate Unit No. 2, accord-
ing to Map thereof No. 6753 filed in said
County Recorder's Office October 9, 1970;
thence along the Southeasterly boundary
line of said Lot 100A South 62°24'22"
West, 48.58 feet to the TRUE POINT OF
BEGINNING; thence leaving said Southeasterly
boundary line South 05°58'54" East, 242.33
feet to a point in the arc of a 1,610.00
foot radius curve concave Southeasterly, a
radial to said point bears North 32°54'25"
West; thence Northeasterly along the arc of
said curve through a central angle of
00°35'49", an arc length of 16.77 feet to
a point to which a radial bears North
32°43'35" West; thence North 05°58'54"
West, 240.74 feet to a point in the South-
easterly boundary line of said Lot 100A;
thence along the said Southeasterly boundary
line South 62°24'22" West, 16.13 feet return-
ing to the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
directed to file a certified copy of this resolution in the
office of the County Recorder of San Diego County.
