

RESOLUTION NO. 203744 SEP 14 1971

WHEREAS, the maintenance of backflow prevention devices on water systems should be the responsibility of the City; and

WHEREAS, the City Manager has, pursuant to San Diego Municipal Code, Section 67.05, recommended that certain monthly fees be charged for maintaining and replacing said backflow prevention devices; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That maintenance and replacement fees for backflow prevention devices shall be as follows:

- a. \$1.00 per month for each backflow prevention device which is 5/8, 3/4, 1, 1-1/2 or 2 inches in size.
- b. \$2.00 per month for each backflow prevention device which is 3, 4 or 6 inches in size.
- c. \$3.00 per month for each backflow prevention device which is 8, 10, 12 inches or larger in size.
- d. A dual backflow prevention device unit shall be charged a monthly fee one and one-half times that charged for either single backflow prevention devices which compose the unit.
