BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$148,825.00 and \$6,440.00 is hereby authorized out of Gas Tax Fund 219 and Capital Outlay Fund 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the City's contribution toward the cost of the improvement of LINDA VISTA ROAD, between Tait Street and Genesee Avenue, ULRIC STREET, between Tait Street and Linda Vista Road, and COMSTOCK STREET, between Ulric Street and Linda Vista Road, pursuant to Resolution of Intention No. 202833, under the 1911 Act proceedings.
