- 2. That the expenditure of \$306,000.00 is hereby authorized out of the Sewer Bond Fund (728) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF REED STREET FORCE MAIN AND PUMP STATION NO. 17 AND SEWER REPLACEMENT IN PACIFIC BEACH DRIVE in the City of San Diego, and related costs.
