RESOLUTION NO. 203789 SEP 21 1971

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That an easement for the purpose of a right of way for the construction, operation and maintenance of a storm drain or drains and appurtenances thereto, through, over, under, along and across the hereinafter described property, be, and the same is hereby set aside for such public purposes:

All that portion of Lot 2 of Block 192 of University Heights in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 558, filed in the Office of the San Diego County Recorder August 6, 1888, being a strip of land 4.00 feet in width more particularly described as follows:

Commencing at the most Westerly corner of said Lot 2; thence along the Southerly boundary line of said Lot 2 North 89°03'30" East, 25.34 feet to the TRUE POINT OF BEGINNING; thence leaving said Southerly boundary line North 00°29'30" East, 20.73 feet to the beginning of a tangent 157.00 foot radius curve, concave Easterly; thence Northerly and Northeasterly along the arc of said curve through a central angle of 05°15'30" an arc length of 14.41 feet to a point to which a radial bears North 84°15'00" West; thence along said radial line South 84°15'00" East, 4.00 feet to the beginning of a 153.00 foot radius curve, concave Easterly, a radial to said point bears North 84°15'00" West; thence Southwesterly and Southerly along the arc of said curve through a central angle of 05°15'30" an arc length of 14.04 feet; thence South 00°29'30" West, 20.73 feet to the Southerly line of said Lot 2; thence along said Southerly line South 89°03'30" West, 4.00 feet more or less to the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
