BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of Murrieta Hot Springs, a California corporation, executed in favor of The City of San Diego, bearing date July 7, 1971, conveying to said City an easement and right of way for street purposes through, over and across all that portion of the Southeast Quarter of the Southeast Quarter of Section 26, Township 14 South, Range 3 West, San Bernardino Base and Meridian, according to the United States Government Survey, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named MONTONGO STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
