

RESOLUTION NO. 203800 SEP 21 1971

WHEREAS, the City has by its Resolution No. 200830, adopted September 22, 1970, authorized the execution of an agreement with the County of San Diego providing that a study of offshore airport sites be conducted by the Ralph M. Parsons Company and be included in the larger study supervised by the San Diego Comprehensive Planning Organization; and

WHEREAS, that agreement provided that the subsequent agreement incorporating the offshore airport study to be conducted by the Ralph M. Parsons Company as a subcontractor would be submitted to City for its approval prior to its execution; and


