BE IT RESOLVED, by the Council of The City of San Diego as follows:

The action of the City Council in denying the request to rezone a portion of the WEST 1/2 of SECTION 30, TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M., from INTERIM ZONE A-1-10 to ZONE R-1-5, located north of Mira Mesa Boulevard and west of Black Mountain Road, be, and it is hereby reconsidered, and RESOLUTION 203749, adopted September 16, 1971, denying said rezoning, is hereby repealed.

BE IT FURTHER RESOLVED, the application to rezone said property is referred back to Planning Commission for further consideration, and the applicant is to bear the cost of renoticing said proposal to rezone.
