BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Lease Agreement with SAN DIEGO VETERANS WAR MEMORIAL BUILDING, INC., as lessee, leasing the Veterans War Memorial Building located in Balboa Park, for a term of one (1) year ending June 30, 1972, at a rental of \$50.00 per month, for the purpose of providing social, cultural, educational and recreational facilities for the benefit of all veterans, veterans' patriotic organizations and other residents of the City of San Diego, and for the purpose of holding convention and civic events, together with the purveying of goods and services by concessioners to tenants and guests, and providing for a City subsidy of \$8,038.00 for the term for operating expenses, under the terms and conditions set forth in the form of Lease Agreement, on file in the office of the City Clerk as Document No. 737464.
