APPROVING MAP OF HOLLY HILLS VISTA UNIT NO. 4 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by NORRIS E. LUEDTKE, Registered Civil Engineer, and entitled, "HOLLY HILLS VISTA UNIT NO. 4 Being a subdivision of portions of Lots 2 through 7 and 21 through 24 of Block K, Narragansett Heights, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1041, filed in the office of the County Recorder of San Diego County, April 5, 1907, together with portions of Potrero Street and Carlsbad Street as dedicated to public use per Map No. 1041.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets and portions of public streets, to wit: Ashmore Avenue, Braun Avenue, San Vincente Street, Ashmore Lane, Worthington Streets, a portion of Potrero Street and a portion of Carlsbad Street, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said

Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
