PLACE.

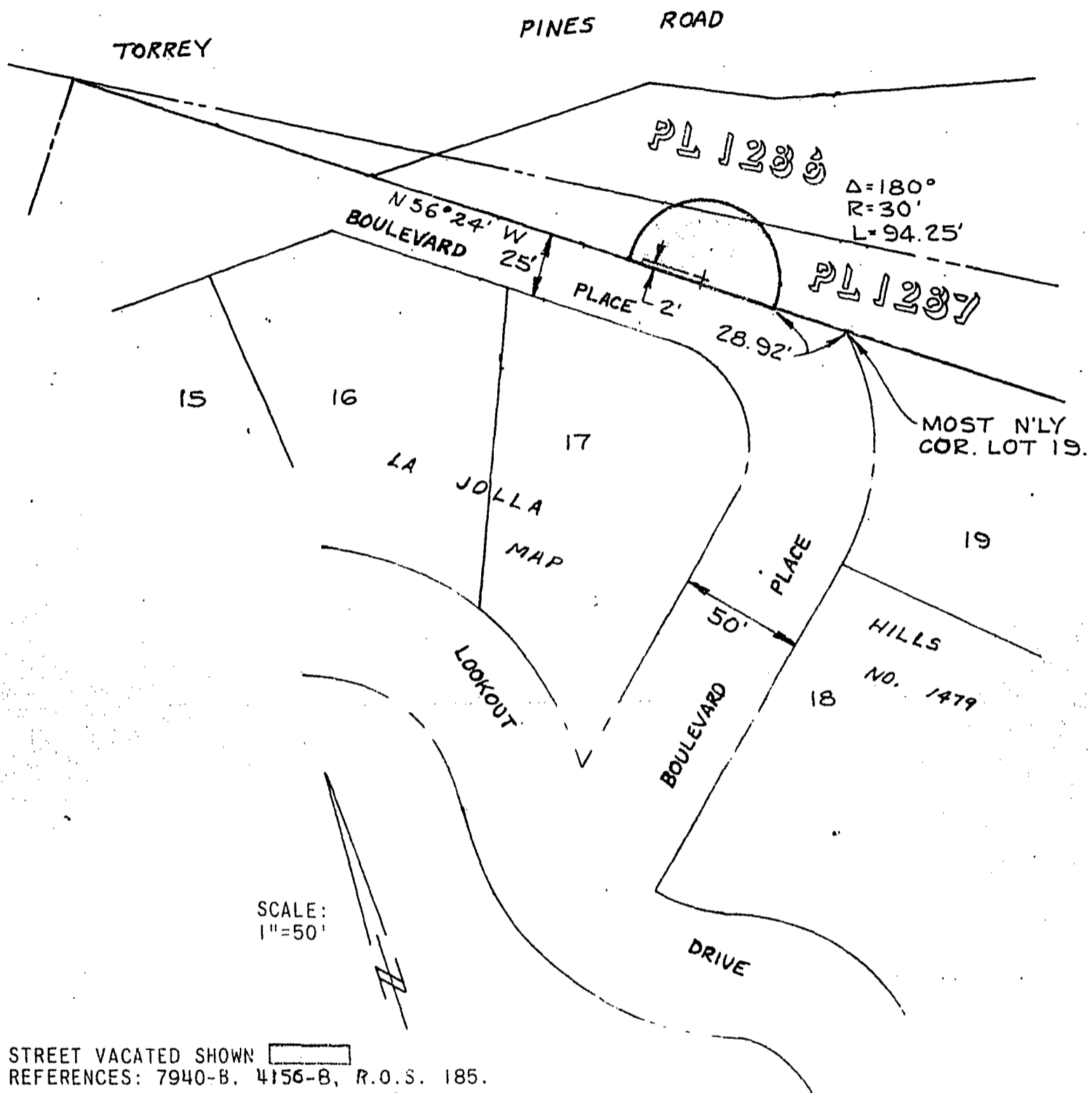
BE IT RESOLVED, By the Council of The City of San Diego,
