BE IT FURTHER RESOLVED, that CLAYTON STREET between Kurtz Street and Hancock Street,

as more particularly shown on Map No. 12601-B on file in the office of the City Clerk as Document No. 737277, which said map is attached hereto marked Exhibit A and made a part hereof, be, and the same is hereby vacated.

BE IT FURTHER RESOLVED, that The City of San Diego reserves and excepts from the foregoing vacation the permanent easement(s) as more particularly shown on Map No. 12601-B , on file in the office of the City Clerk as Document No. 737277, and as more particularly described hereinafter:

Res. Ordering Vacation--easements required -- 2

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating sewer facilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City of the right to utilize the said easement herein, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

The easement reserved herein is in, under, over, upon, along and across the following described property:


All that portion of Clayton Street as vacated, as established according to the map of Middletown according to Partition Map thereof made by J. E. Jackson, on file in the office of the County Clerk of San Diego County, lying 7.50 feet on each side of the following described centerline:

Beginning at the most westerly corner of Lot 1, Block 182 of said Middletown; thence Northwesterly along the Northwesterly prolongation of the Southwesterly line of Block 182, a distance of 21.00 feet to the TRUE POINT OF BEGINNING of the herein described centerline; thence deflecting 90°00'00" to the right a distance of 169.00 feet to a point; thence deflecting 43°09'20" to the left to a point, said point being the intersection of said centerline with the Northwesterly prolongation of the Northeasterly line of Block 182, and also being the point of termination of the herein described centerline.

The side lines of the above described easement shall be lengthened and/or shortened so as to terminate in the boundaries of the above described land.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, including the attached Exhibit A, attested by him under seal, to be recorded in the office of the County Recorder.
