

RESOLUTION NO. 203891 OCT 5 1971

WHEREAS, in accordance with Streets and Highways Code, Section 256, the California Department of Public Works, Division of Highways is conducting a study of the California State Highway System; and

WHEREAS, the State proposes a transportation corridor be established in the North City area; and


WHEREAS, designation of the corridor by the Legislature will allow a corridor planning study to be initiated. Each local government involved will become a full partner in the transportation corridor study and may assign its own members to the study team; and

WHEREAS, the transportation corridor study will include other modes of transportation and would attempt to identify the specific mode or combination of modes best suited to provide service within the corridor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council urges the California Highway Commission to recommend to the Legislature adoption of a transportation corridor in the North City area.
