BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$26,031.00 by ABC Paving Company, Inc., a corporation for the IMPROVEMENT OF BALBOA AVENUE BETWEEN INTERSTATE 5 AND MOUNT CULBERA AVENUE FOR CONSTRUCTION OF WALKWAY AND GUARD RAIL, using Schedule II in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 736439.
2. That the expenditure of \$32,000.00 is hereby authorized out of the Gas Tax Fund 220 of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF BALBOA AVENUE BETWEEN INTERSTATE 5 AND MOUNT CULBERA AVENUE FOR CONSTRUCTION OF WALKWAY AND GUARD RAIL, using Schedule II in the City of San Diego, and related costs.
