

RESOLUTION NO. 203904 OCT 7 1971

APPROVING MAP OF BAY TERRACES UNIT NO. 12 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by EARL R. RICHARDSON, Licensed Land Surveyor, and entitled, "BAY TERRACES UNIT NO. 12 Being a subdivision of a portion of Quarter Section 55 of Rancho de la Nacion in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 166 filed in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Woodman Street, adjacent and contiguous to Lot 1022, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of general utility facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of general utility facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
