The City Manager is hereby authorized and empowered to execute, for and on behalf of City, an agreement with THE CHRISTIANA COMPANIES, INC., a Delaware corporation, for the construction of improvements on Robusto Road, including curb, sidewalk, sewer, water and street light installation, within the limits of VILLA MONSERATE UNIT NO. 4 subdivision, and to provide for reimbursement by the City out of Capital Outlay Fund 245, in an amount not to exceed \$15,720.00, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 737608.
