RESOLUTION APPROVING PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 203463 FOR THE IMPROVEMENT OF HYATT STREET, EAST HYATT STREET, FULTON STREET, WEST INGERSOLL STREET, EAST INGERSOLL STREET, NORTH JUDSON STREET, JUDSON STREET, RICHLAND STREET AND GATLING COURT.

WHEREAS, this City Council did on August 17, 1971, adopt Resolution of Intention No. 203463 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the proposed work to be done in said Resolution of Intention, and that said Resolution of Intention be amended to delete sidewalks around church property at Fulton Street and Judson Street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the plans, drawings, typical cross-sections, profiles and specifications for the improvement of HYATT STREET, EAST HYATT STREET, FULTON STREET, WEST INGERSOLL STREET, EAST INGERSOLL STREET, NORTH JUDSON STREET, JUDSON STREET,

RICHLAND STREET and GATLING COURT, heretofore filed in the office of the City Clerk as Document No. 736908 and approved by Resolution No. 203462, be, and the same is hereby amended to conform with Drawing Nos. 14531-1-D and 14531-2-D, filed in the office of the City Clerk as Document No. 737637, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.
