Such notice shall state that the Purchasing Agent is the officer designated by the City Council to receive such bids and such notice shall give the time and place of the opening of any bids so received; and the Purchasing Agent is hereby directed to publish twice in the City Official Newspaper a notice inviting such proposals for doing the work; and the Purchasing Agent is hereby directed to record the results of such bidding to the City Council at the next regular City Council meeting after the opening of the bids.
