

RESOLUTION NO. 203922 OCT 12 1971

WHEREAS, pursuant to the Resolution of Intention No. 203323, a public hearing was held on September 14, 1971 to consider a project establishing a parking and business improvement area to be known and denominated as the North Park Parking and Business Improvement Area and the levying of an additional business license tax and annual ad valorem special assessment therein; and
