That the expenditure of \$14,567.02 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the City's contribution toward the cost of the improvement of MISSION BOULEVARD, from Pacific Beach Drive to Loring Street, and LA JOLLA BOULEVARD, from Loring Street to Turquoise Street, under the 1911 Act proceedings, pursuant to Resolution of Intention No. 203149.
