
WHEREAS, under the terms of Public Law 89-136 as amended, the United States of America has authorized the making of grants to public bodies and private or public nonprofit organizations or associations to aid in financing the construction of specific public projects:

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of San Diego as follows:

1. That the City Manager is hereby authorized to execute and file an application on behalf of The City of San Diego with the Economic Development Administration, U. S. Department of Commerce, for a grant to aid in financing the replacement of existing and construction of new sidewalks within the Southeast San Diego and San Ysidro communities.

2. That the City Manager is hereby authorized and directed to furnish such information as the Economic Development Administration, U. S. Department of Commerce may reasonably request in connection with the application which is herein authorized to be filed.
