

RESOLUTION NO. 203981 OCT 14 1971

APPROVING MAP OF SCRIPPS VILLAGE CENTER UNIT NO. 3 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "SCRIPPS VILLAGE CENTER UNIT NO. 3 Being a subdivision of portions of the West Half of Section 4 and the East Half of Section 5, both in Township 15 South, Range 2 West, San Bernardino Meridian, according to official Plat thereof, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that ~~said map and the subdivision of land shown thereon is hereby approved~~ and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of public street, to wit: Aviary Drive, Willow Creek Road and a portion of Pomerado Road, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement, with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, is accepted on behalf of the City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
