RESOLUTION AMENDING RESOLUTION OF INTENTION NO. 203414 BY APPROVING PLANS AND PROFILES SHOWING CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED THEREIN FOR THE IMPROVEMENT OF GENESEE AVENUE, MARLESTA DRIVE, LINDA VISTA ROAD AND MOUNT ALIFAN DRIVE; AND FURTHER APPROVING AN INCREASE IN THE CITY'S CONTEMPLATED CONTRIBUTION IN THE AMOUNT OF \$49,500.00.

WHEREAS, this City Council did on August 12, 1971, adopt Resolution of Intention No. 203414 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that (1) certain changes and modifications be made in the plans, profiles and drawings adopted by said Resolution of Intention, and (2) that said Resolution of Intention be amended to include an additional contribution by the City of \$49,500.00 out of Gas Tax Funds; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of GENESEE AVENUE, MARLESTA DRIVE, LINDA VISTA ROAD and MOUNT ALIFAN DRIVE, heretofore filed in the office of the City Clerk as Document No. 736842 and approved by Resolution No. 203413 be, and the same are hereby amended to conform with Drawing Nos. 14609-6-D, 14609-7-D and 14609-12-D, filed in the office of the City Clerk as Document No. 737739, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.

2. That Resolution of Intention No. 203414 be amended by increasing the contemplated contribution of The City of San Diego in the amount of \$49,500.00, said sum to be expended out of Gas Tax Funds.
