APPROVING MAP OF MIRA MESA VERDE UNIT NO. 7 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
Said Council hereby finds that that certain map surveyed
by WILLIAM J. CLARKE, Licensed Land Surveyor, and entitled,
"MIRA MESA VERDE UNIT NO. 7 Being a subdivision of the Northeast
Quarter of the Northwest Quarter of Section 31, Township 14 South,
Range 2 West, San Bernardino Meridian in the City of San Diego,
County of San Diego, State of California, according to the official
Plat thereof, excepting therefrom the East 25 Acres thereof, also
excepting from the above described land lying Westerly of the East
25 Acres, the South 3 Acres thereof," is made in the manner and
form prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is hereby
approved and accepted; and said Council hereby accepts on behalf
of the public the public streets, to wit: Dewsbury Avenue, Decatur
Road, Clover Circle, Decatur Circle and Amberly Circle for public
purposes and said streets are hereby declared to be public streets
and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map and that said
public streets are accepted on behalf of the public as heretofore
stated.

Said City Clerk is hereby directed to transmit said map
to the Clerk of the Board of Supervisors of the County of San
Diego, California.
