That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the MISSION BAY LESSEES' ASSOCIATION, a nonprofit California corporation, to operate an advertising and promotional program designed to increase the year-round use of Mission Bay Park and to gain national recognition of Mission Bay Park as an aquatic recreational area for the period July 1, 1971 to June 30, 1972, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 737777.
