

RESOLUTION NO. 204051

WHEREAS, the California State Legislature has before it Assembly Bill 3050 endeavoring to establish a San Diego Council of Governments; and

WHEREAS, said Assembly Bill 3050 has within it a regional voting formula which does not reflect the concept of one man-one vote; and

WHEREAS, this City Council believes that each city should receive a vote commensurate with its proportionate population in the region defined within Assembly Bill 3050;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Assembly Bill 3050 should be amended to reflect the concept of one man-one vote wherein each city receives a weighted vote in a proportion which its population bears to the total population of the region.
