Carol E. Hopkins	PROPERTY DEPARTMENT	\$30	The use of a standard form letter for a frequent communication has resulted in the saving of about \$300 worth of clerical time.
Joseph F. Young	PUBLIC WORKS DEPARTMENT	\$15	A special panel saw was purchased as was suggested. This saves considerable time in the operation of sawing large sheets of material such as plywood. Estimated net savings are \$150 per year, but this may amount to much more at the present rate of use.
Virginia R. Edwards	PUBLIC RELATIONS DEPT.	\$10	It was proposed and is now in effect that a charge of \$1.00 be made for City Directories requested by others than City employees. These were formerly given out without charge.
